He served on the IFRS Interpretations Committee from July 2014 to June 2020 and was a member of the Financial Reporting Standards Committee of South Africa. He also served as Chair of the Standard Setters Committee of PAFA (Pan African Federation of Accountants).

Bruce qualified as a Chartered Accountant and Registered Auditor in South Africa. He worked in the Deloitte IFRS Centre of Excellence in London before moving to Barclays Capital.



Vincent Papa
